The Sointula Volunteer Fire Department needs to have its current tax cap increased significantly to meet its operational and capital needs. Demands of the fire department include:

- To meet WorkSafe BC standards means that turnout gear needs to be replaced every 10 years at over \$3,000 per member
- To meet BC Fire Commissioner training standards, more funds are needed for courses to be taken and skills to be maintained
- In ten years, the department will be needing to replace its pumper truck at an estimated cost of \$590,000
- Critical equipment such as air packs will need replacing/upgrading in the next decade

The current tax cap for funding the fire department is \$41,000/year and was set back in 2004. This level of funding could cover the operational costs, but leaves very little to save for a new truck. It has no ability to increase as costs rise due to inflation.

The Virtual Community Meeting will explain what the fire department is doing now, its plans, and what funding is required. The meeting will also explain what options are available to fix the funding challenge.
