



**REGIONAL DISTRICT OF MOUNT WADDINGTON**

**BYLAW NO. 843**

*A bylaw to amend the "Woss Street Light Local Service Establishment Bylaw No. 565" to provide for an increase in the maximum amount for annual operations cost.*

**WHEREAS** by Bylaw No. 565, 1998 the Regional District of Mount Waddington established a local service for the provision of a street lighting service within a portion of Electoral Area "D";

**AND WHEREAS** by Bylaw No. 565, 1998 the maximum amount that may be expended annually for the cost of the service is the greater of nine thousand, five hundred dollars (\$9,500) or an amount equal to the amount that may be raised by a property value tax of \$0.743 per one thousand (\$1000) dollars;

**AND WHEREAS** the Regional District of Mount Waddington deems it necessary to increase the maximum limit to accommodate increased annual costs;

**AND WHEREAS** the proposed increase is within 25% over a five year period;

**AND WHEREAS** written consent, attached to and forming part of this bylaw, has been given on behalf of the Electors by the Electoral Area "D" Director to amend Bylaw No. 565;

**NOW THEREFORE** the Board of the Regional District of Mount Waddington in open meeting assembled hereby enacts as follows:

1. **THAT** Bylaw No. 565, 1998 Section 5(b), is amended by striking out the expression of \$0.743 per one thousand (\$1000) dollars and replacing with the expression \$0.92875 per one thousand (\$1000) dollars.
2. **THAT** this bylaw be cited as "Woss Street Lighting Local Service Establishment Amendment Bylaw No. 843, 2013".
