



REGIONAL DISTRICT OF MOUNT WADDINGTON

QUATSINO PUBLIC WHARF SERVICE ESTABLISHMENT BYLAW NO. 950, 2018

A bylaw to provide a Public Wharf service for the benefit of the residents of the community of Quatsino.

WHEREAS the *Local Government Act* empowers a regional district to operate any service that its Board considers necessary or desirable for all or part of the Regional District;

AND WHEREAS the Board of Directors of the Regional District of Mount Waddington ("the Board") wishes to establish a service for operating and maintaining a public wharf facility in Quatsino;

AND WHEREAS the Board has obtained participating area approval by alternative approval process in accordance with the *Local Government Act* and of the Community Charter;

NOW THEREFORE the Board of the Regional District of Mount Waddington in open meeting assembled enacts as follows:

1. SERVICE

The Regional District of Mount Waddington hereby establishes a service area to provide public wharf operations and maintenance services in Quatsino, to be known as the "Quatsino Public Wharf Service" (the "**Service**").

2. PARTICIPATING AREA AND SERVICE AREA

The participating area and the service area for the Service is that portion of Electoral Area "C" as shown outlined on Schedule "A" (the "**Service Area**") attached hereto and forming part of this bylaw.

3. COST RECOVERY

The annual costs of providing the service shall be recovered by one or more of the following:

- a. the imposition of a property value tax;
- b. the imposition of fees and charges;
- c. revenues raised by other means authorized under the *Local Government Act* or another Act;
- d. revenues received by way of agreement, enterprise, gift, grant or otherwise;
- e. a combination of the above.

4. MAXIMUM REQUISITION

The maximum annual amount that may be requisitioned for the **Service** is zero.

5. POWERS

To operate this service, the Regional District may:

- a) Acquire land and/or equipment necessary to operate a Public Wharf facility;
- b) enter into service agreements for the provision and maintenance of the service;
- c) by bylaw, establish a Quatsino Local Service Management Committee for the purpose of providing advice with respect to operation of the service;

6. REVIEW PROCESS

The Bylaw will be reviewed by the Regional District Board five years after adoption and every five years thereafter.

7. CITATION

This Bylaw may be cited as the "Regional District of Mount Waddington Quatsino Public Wharf Service Area Establishment Bylaw No. 950, 2018".
