



REGIONAL DISTRICT OF MOUNT WADDINGTON

BYLAW NO. 830

A bylaw to establish a Heritage Conservation Service for the benefit of Electoral Areas C and D in the Regional District of Mount Waddington.

WHEREAS the Regional District of Mount Waddington, pursuant to the provisions of the *Local Government Act*, may, by bylaw, establish and operate a service relating to heritage conservation; and

WHEREAS the Board of Directors has authorized approval of this bylaw to be obtained under sections 801(2)(d) and 800.1(2)(h) of the *Local Government Act* and has authorized electoral participating area approval to be given under section 801.5; and

WHEREAS the directors of Electoral Areas C and D have consented in writing to the adoption of this bylaw;

NOW THEREFORE the Board of the Regional District of Mount Waddington, in open meeting assembled, hereby enacts as follows:

1. Establishment of the Service

1.1 In the Regional District of Mount Waddington heritage conservation is established as a service called the Regional District of Mount Waddington Heritage Conservation Service.

1.2 The Board is hereby empowered to carry out, or cause to be carried out, heritage conservation services in and for the identified service area and do all things necessary or convenient in connection therewith, including the establishment of a Community Heritage Register, in accordance with Part 27 of the *Local Government Act*, the *Community Charter*, the *Land Title Act* and the *Heritage Conservation Act*.

2. Service Area

2.1 The participants of the service and the boundary of the service area are Electoral Areas C and D.

3. Method of Cost Recovery

3.1 The costs of providing the service established in clause 1.1 shall be recovered by a requisition under Section 803(1)(a) of the *Local Government Act*.

3.2 The amount requisitioned must be collected by a property value tax on the net taxable value of land and improvements according to Section 806.1(a) of the *Local Government Act*.

4. Maximum Requisition

4.1 The maximum annual amount that may be requisitioned for the Service will not exceed \$4000.

5. Citation

This Bylaw may be cited as the "Regional District of Mount Waddington Electoral Areas C and D Heritage Conservation Service Establishment Bylaw No. 830, 2011".

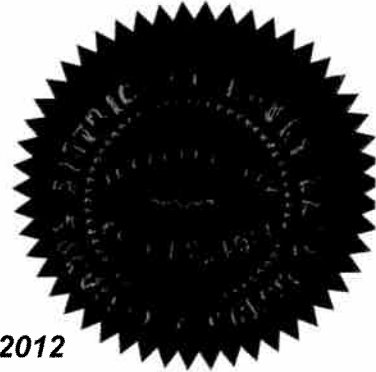
