- *Regulations and tenure issuance are the responsibility of senior governments who should be accountable for making these decisions*
- *The public hearing provided a local opportunity for public input into the broader issues that should be considered, including those outside the authority of the RDMW*
- *Land based fishfarms would address many of the concerns raised at the public hearing*
- *Visual and noise issues are a concern, and may result in a depreciation of property values*
